
UNFINISHED BUSINESS:


WHEREAS, pursuant to state law, the Town Board of Trustees shall appoint a Town Attorney; and,

WHEREAS, the Town Board of Trustees desires to appoint Dan Slater, Attorney at Law as the Town of Rockvale Town Attorney.


**NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES



RESOLUTION NO 5 - SERIES 2026

A RESOLUTION APPROVING THE EXPENDITURE OF EIGHT THOUSAND DOLLARS (\$8,000) FOR THE MAY PARK BOUNDARY SURVEY

WHEREAS, the Town of Rockvale, Colorado ("Town") is committed to providing safe, accessible, and well-planned parks and recreational facilities for the benefit of its residents; and

WHEREAS, the Town desires to gather input and professional data to support informed decision-making regarding current and future May Park planning, improvements, and development; and,

WHEREAS, the Town has identified the need to allocate funds in the amount of Eight Thousand Dollars (\$8,000) for the purpose of conducting such a May Park boundary survey; and

WHEREAS, the Town has approved the boundary survey to mark the property corners, create a drainage easement for the west ditch, petition to remove existing property lines to create one (1) parcel, remove the alley way in the middle, and an as-built for existing features.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN BOARD OF TRUSTEES OF THE TOWN OF ROCKVALE, COLORADO, THAT:

1. The expenditure of Eight Thousand Dollars (\$8,000) is hereby approved for the purpose of conducting a May Park boundary survey for the Town of Rockvale.
2. The Town Mayor, Town Clerk, and other appropriate Town officials are authorized to take all actions necessary to carry out the intent of this Resolution.





RESOLUTION FOR EXEMPTION FROM AUDIT

(Pursuant to Section 29-1-601, C.R.S.)

A RESOLUTION APPROVING AN EXEMPTION FROM AUDIT FOR FISCAL YEAR 2025 FOR THE TOWN OF ROCKVALE, STATE OF COLORADO.

WHEREAS, the Board of Trustees of the Town of Rockvale wishes to claim exemption from the audit requirements of Section 29-1-603, C.R.S.; and

WHEREAS, Section 29-1-604, C.R.S. states that any local government where neither revenue nor expenditures exceed one million dollars may, with the approval of the state auditor, be exempt from the provisions of Section 29-1-603, C.R.S.; and

WHEREAS, neither revenues nor expenditures for the Town of Rockvale exceeded \$1,000,000 for fiscal year 2025; and

WHEREAS, an application for exemption from audit for the Town of Rockvale has been prepared by Lenny Merriam, with knowledge of government accounting; and

WHEREAS, said application for exemption from audit completed in accordance with regulation issued by the state auditor.

NOW THEREFORE, be it resolved by the Board of Trustees of the Town of Rockvale that the application for exemption from audit for the Town of Rockvale for the fiscal year ended December 31, 2025, has been personally reviewed and is hereby approved by a majority of the Board of Trustees of the Town of Rockvale; that those members of the Board of Trustees have signified their approval by signing below; and that this resolution shall be attached to, and shall become a part of the application for Exemption from Audit of the Town of Rockvale for the fiscal year ended December 31, 2025.





WHEREAS, the residents of the Town of Rockvale, through their water bill must pay for the Regional Water System debt retirement, the Town of Rockvale's debt retirement, the costs of the water system – administration, repair, testing and saving money to address major system repair; and

WHEREAS, these fixed charges are allocated equally and evenly to all water taps on the water system; and

WHEREAS, the monthly costs for testings which are mandated by the State of Colorado and Federal requirements and all other water related items incurred by the Town of Rockvale have continually been increasing:

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF ROCKVALE, COLORADO:

The water rates are set as follows:

Base Rate \$56.00 plus:

Acquisition Fee \$2.00 plus:

Usage:

\$4.00 per 1,000 gallons (or any portion thereof) up to 4,999 gallons

\$5.00 per 1,000 gallons (or any portion thereof) from 5,000 to 9,999 gallons

\$6.00 per 1,000 gallons (or any portion thereof) from 10,000 to 14,999 gallons

\$7.00 per 1,000 gallons (or any portion thereof) from 15,000 to 19,999 gallons

\$8.00 per 1,000 gallons (or any portion thereof) from 20,000 to 24,999 gallons

etc.






